Overview

MARINet is a consortium of seven public libraries and two academic libraries in Marin County, all of whom share a single library catalog and most of their collections of physical and shared online resources. Your library card from any one of these libraries is valid at any MARINet library. With certain exceptions, library patrons can borrow items from any MARINet library and return them to any MARINet library.

MARINet is short for "Marin Automated Resources and Information NETwork" and operates as a Special District, created as a Joint Powers Agency under the County of Marin, and registered with the Office of the California Secretary of State. Governance and funding for MARINet is provided by the member libraries under a formula contained in the <u>JPA (Joint Powers Agency) agreement of 1997</u>. The initial mission was to create a shared library catalog in the 1990's, but we have expanded to provide delivery services, an <u>Overdrive collection available to all libraries</u>, <u>numerous other shared online resources</u>, and since 2017 the network connections for the public libraries in the consortium, through <u>CENIC</u>.

MARINet's Mission

The mission of the Marin Automated Resources and Information Network (MARINet) is to function as a consortium of libraries which enables its members to share resources and use information technology to fulfill their missions of serving the public.

MARINET was established by a Joint Powers Agreement on June 12, 1991. It is governed by a Board consisting of the directors of the member libraries. The current JPA which MARINET operates under is dated July 8, 1997 and is

available at <u>MARINet Joint Powers Agreement</u> (PDF). Addendums to the JPA were made to add members in 1997, 2001, 2010 and 2013, and all these JPA-related documents are <u>available online</u>.

MARINet Board

The MARINET Governing Board is composed of the directors of each of the nine member libraries. One director serves as chair each year, elected by the board members at the June meeting. A Vice Chair is also selected in June, and traditionally the Vice Chair of each year becomes Chair the following year.

The Board chair starting in 2023 is Lana Adlawan of the Marin County Free Library. The Vice Chair is Crystal Duran of the Belvedere Tiburon Library.

Board members and the Board's Chair and Vice Chair serve on the MARINet Board as part of their duties as library directors of their respective agencies. They are not compensated nor reimbursed for expenses by MARINet in connection with membership on the Board.

Budget and Finance

MARINet is funded by its member libraries, according to a formula set out in the <u>1997 Joint Powers Agreement</u> governing MARINet. Funding for the original purchase of the online system was provided by the member jurisdictions and by a grant from the Marin Community Foundation.

These annual charges to libraries are the sole source of funding for MARINet. All fees and fines paid on the MARINet website are distributed to the member libraries or to their governing agencies, based on which library owns the item the fine is being paid on.

The current (fiscal year 2022-23) MARINet Budget is \$1,951,485. This includes 5% (\$88,592) for reserves, and \$292,000 for Overdrive online content purchased by MARINet staff.

The funding formula is revised after Jan. 1 of each year, and after being approved by the Board, takes effect for the following fiscal year on July 1. The funding formula is determined by combining three factors:

- 1. The population served by each member library's jurisdiction according to the California State Library, or for academic members, Fall enrollment figures
- 2. The circulation figures for the previous year, which is checkouts and renewals done by the residents of each member library's jurisdiction
- 3. The number of items each jurisdiction has in their collection on Jan. 1 of each year
