

The district is actively addressing its net pension liability and future pension costs by currently exploring multiple courses of action. Beginning in July 2015, the Classic CAL-PERS members in the unrepresented employee group began paying one third of the employee cost, and this employee group will increase its pension contribution each July until it pays 100% of the employee share beginning in July 2017. The district is also exploring establishing a pension trust through the Community College League of California, Pension Rate Stabilization Program (PRSP). In addition, the district will begin discussions with its collective bargaining groups to negotiate employee pension rates and responsibility.
