# **#1: Transite Water Line Replacement**


- Projected ROM for 2024/5: \$700,000
- Category: Infrastructure, Safety, Fire
- Description: Transite is an outdated water line system that is susceptible to breaks and leakage. This represents domestic and irrigation water lines replacing with C900 plastic piping that meets code for domestic water lines.







- Projected ROM for 2024/5: \$1,250,000
- Category: Safety, Fire, ADA, Infrastructure
- **Description:** Repaying for lots 9, part of 7, 15, 16, 2, 11, and 12 Resealing for lots 6, rest of 7, 1, 4, 10 Restriping for all of the above Micro-seal for lot 13











# **#5: Re-roofing of Student Services Building**

- Projected ROM for 2024/5: \$350,000
- Category: Infrastructure
- **Description:** Not sure if original but definitely old and leaks.










# #6: Micro-grid for the KTD campus

- Projected ROM for 2024/5: \$10,000,000

- Description: Major infrastructure project that would reduce or eliminate our need to be on the grid or help during major power outages.








# **#8: HVAC Filtration Upgrades**

- **Description:** Continuation funding to meet the needs of the project.






#### **#11:** New Creek Bridge at Entrance of Student Services and LRC

- Description: Pool plastered falling apart and needs to be replaced. Was not replaced when building was renovated in Measure C











## **#17: Bleachers**




