Behind-the-scene machinery that District purchased.

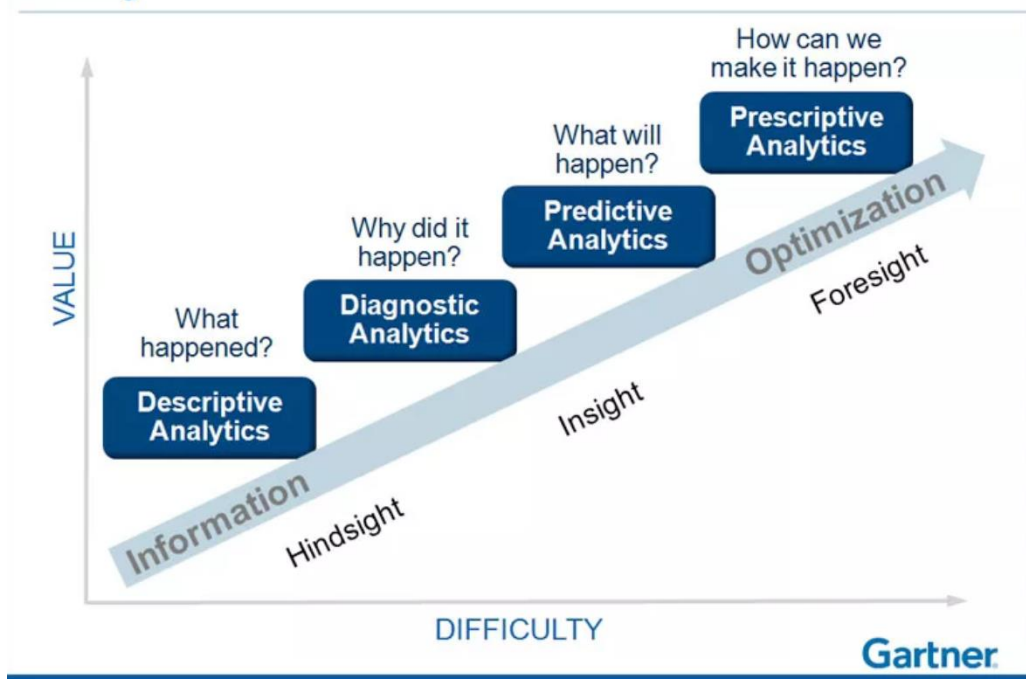
Equipment including but not limited to computers, laptops, screens, phones.

II. Discussion: Questions and Answers

1. Incorporating data analytics, how does IT differentiate from services of PRIE?

IT provides tools for PRIE who is at the frontline to provide services. Another area that IT does to support data flow is the overtime request and approval process. IT supports the data moving through the college.

2. Heather asked was there any Hybrid room to be outfitted in IVC? Not yet. Patrick asked Stacey to speak about modality first. IT could not outfit the classrooms before COM determines on delivery mode.

Stacey stated that COM does not have a working definition for "dual delivery" yet. The DE Committee composed a task force and the effort of researching the best practice is underway.

3. Josh asked about the AI Bot (Ocelot) availability – Patrick answered it would be released in an about month.

Josh also asked about Qualtrics survey. Patrick answered that IT projected to gather student experiences in Jan/Feb 2023.

4. Grace asked about any tactics to reduce robo-calls. Patrick said that there was nothing now for combatting robo-calls or scam-calls. The challenge was that robo-call phone number was different each time.

5. Grace asked about opening the COM-Limited Wireless network to have more speed.

Patrick responded that due to security concerns and the need to know each person's identification, the COM-limited wireless network could not be opened more.

6. When asked about the community engagement, Patrick said that he sits on the Marin Security and Privacy Council of Marin County. COM is always ready to step in wherever we are needed.
