Revised Procedures for Public Meetings using Zoom

Pursuant to Assembly Bill (AB) 361, (https://leginfo.legislature.ca.gov/faces/billTextClient.xhtml?bill_id=202120220AB361) Government Code Section 54953 now authorizes public agencies to hold virtual meetings during a proclaimed state of emergency and remain in compliance with the Brown Act (Gov. Code Sections 54950 et seq.) provided the requirements of Section 54953 are met.

The meeting will be conducted via Zoom and the public may attend via Zoom conference only (but not in-person). Trustees and staff will also attend via video conference.

PUBLIC COMMENT PROCEDURES:

There are two ways to make a public comment at the board meeting 1) in advance by submitting an online form (must be present for comment to be read aloud) or 2) by using the Zoom raise hand feature during the meeting at the scheduled public comment portion of the agenda. Public comment is limited to 3 minutes per speaker, and 15 minutes total per topic.

ONLINE FORM:

Online public comments may be submitted in advance, no later than one hour before the start time on the day of the meeting using the public comment web form at http://forms.marin.edu/form/public-comments. Comments will be read aloud by District staff for the record, if the person submitting the comment is present, otherwise it will be sent to the Board as correspondence. Alternatively, members of the public may use the Zoom "raise hand" feature, described below, to read your comment to the Board of Trustees. Public comment is limited to 3 minutes per speaker (calculated at approximately 300 words). If your comment is regarding a particular item on the agenda, your comment will be taken up at the time the Board takes up that item.

ZOOM RAISE HAND FEATURE:

Members of the public may make a live comment joining the Zoom board meeting by computer or phone, up to 3 minutes. The procedure for remote public comment, for this Board Meeting via Zoom, is as follows:

- If you wish to make a comment, you will need to "raise your hand" when the Board President requests public comment. If your comment is related to an agenda category/section (identified on the agenda by a letter such as A, B, C., etc.), please "raise your hand" when the Board President asks for comments regarding that agenda category/section.
• If participating by computer or the Zoom app, you may "raise your hand" with the Zoom feature on your screen.
• If participating by dial-in phone, you may "raise your hand" by dialing *9.
• After you raise your hand, you will be recognized by the president of the Board, asked to unmute yourself and provide your full name.
• You may comment up to three (3) minutes. The Board clerk will notify you when your time has run.
